POSTNET'S RESPONSIBILITIES

PostNet's customary build-out is typically performed in an 800 - 1200 sq. ft. space (secured by Franchisee) that meets the following specifications:

Vanilla Shell

Franchisee's unit is to be delivered to PostNet in "vanilla shell" condition. For the purpose of this Attachment B, "vanilla shell" is outlined as follows:

- Finished interior walls ready for paint.
- Finished ceiling
- Finished floor (ready for floor covering)

Restroom facilities, renovation in the storage or receiving area, electrical outlets, telephone lines, HVAC, lighting and/or sprinkler systems are not within the scope of PostNet's responsibilities.

Mailbox Structure

The mailbox structure will be built according to Franchisee's approved layout and finished according to plan. The typical mailbox structure is approximately ten (10) feet long and three (3) feet wide. Includes installation of 24-hour access gate.

Installation

Services include the installation of the main service counter modules, placement and installation of packaging and equipment stations (hardware included), installation of the private mailboxes, and placement of the convenience counters as called for in the plan.

Slatwall Installation

PostNet provides color coordinated 4' x 8' interior slatwall wall boards. The plan will call for placement of slatwall around the perimeter of the location.

Interior Painting and Signage Installation

PostNet will paint all service and retail areas visible to the customer per PostNet specifications and install the PostNet proprietary signage listed in this Exhibit.

Carpeting, Tile, and Base Molding

PostNet will provide carpet and installation of the carpet and base moldings from the service area behind the counter through the retail area of the store and a tile entryway. PostNet does not carpet the backroom, storage or receiving area, or any areas that would not be exposed to the customer. Carpeting consists of commercial grade carpet tiles that are glued directly to the floor. All carpeted areas will be finished with 4" vinyl base molding.

Electrical/Wiring

PostNet will provide the CAT5 cabling for the networking of the computers listed in this Exhibit (or may opt to utilize a wireless network) and the speaker wiring for the sound system. All electrical work is the Landlord or Store Owner's responsibility.

Assignment of Warranties

PostNet will assign to Store Owner any warranties on equipment included as part of the leasehold improvements provided by PostNet that may be provided by the equipment manufacturer or vendor.

Conformance with Laws and Codes

PostNet will provide all leasehold improvements in compliance with all local building laws and regulations.

STORE OWNER'S RESPONSIBILITIES

- Compliance with all State, County, and Municipal business licenses and applicable taxes and/or fees.
- Compliance with all State, County, and Municipal sales and/or use tax licenses.
- Purchase of business liability and premises insurance.
- Obtaining all building inspections and approvals, occupancy and/or construction permits, and architectural drawings, if required in Franchisee's locale.
- Applicable sign permit costs and final electrical connection to exterior sign.
- Installation of track lighting in compliance with local codes.
- Provision of electrical connection for track lighting and above-ceiling electrical outlets for neon window signs.

Materials and/or equipment identified in this Attachment B may be substituted at the sole and absolute discretion of PostNet with products of equal or greater value or performance.

| the receipt of which is hereby acknowledged, Guarantors jointly and severally agree as follows: |
| A. <u>GUARANTEE</u> |
| 1. Guarantors shall pay or cause to be paid to PostNet all monies payable by Store Owner under the Franchise Agreement on the date and in the manner required for payment. |
| 2. Guarantors unconditionally guarantee full performance and discharge by Store Owner of all the obligations of Store Owner under the Franchise Agreement on the date and times and in the manner required. |
| 3. Guarantors shall indemnify and save harmless PostNet and its affiliates, and their respective shareholders, directors, employees, and agents, against and from all losses, damages, costs, and expenses which PostNet and its affiliates may sustain, incur, or become liable for by reason of: |
| a. Store Owner's failure to pay the monies payable pursuant to the Franchise Agreement or to do and perform any other act, matter, or thing required by the Franchise Agreement; or |
| b. any action by PostNet to collect money from, or obtain performance by, Store Owner of any act, matter, or thing required by the Franchise Agreement. |
| 4. PostNet shall not be obligated to proceed against Store Owner or exhaust any security from Store Owner or pursue or exhaust any remedy, including any legal or equitable relief against Store Owner, before proceeding to enforce the obligations of the Guarantors herein set out, and the enforcement of such obligations may take place before, after, or contemporaneously with, enforcement of any debt or obligation of Store Owner under the Franchise Agreement. |
| 5. Without affecting the Guarantors' obligations under this Guarantee and Covenants, PostNet, without notice to the Guarantors, may extend, modify, or release any indebtedness or obligation of Store Owner, or settle, adjust, or compromise any claims against Store Owner. Guarantors waive notice of amendment of the Franchise Agreement and notice of |

demand for payment or performance by Store Owner.

6. Guarantors' obligations hereunder shall remain in full force and effect, and shall be unaffected by: (i) the unenforceability of the Franchise Agreement against Store Owner; (ii) the termination of any obligations of Store Owner under the Franchise Agreement by operation of law or otherwise; (iii) the bankruptcy, insolvency, dissolution, or other liquidation of Store Owner, including, without limitation, any surrender or disclaimer of the Franchise Agreement by the trustee in bankruptcy of Store Owner; (iv) PostNet's consent or acquiescence to any bankruptcy, receivership, insolvency, or any other creditor's proceedings of or against Store Owner, or by the winding-up or dissolution of Store Owner, or any other event or occurrence which would have the effect at law of terminating the existence of Store Owner's obligations prior to the termination of the Franchise Agreement; or (v) by any other agreements or other dealings between PostNet and Store Owner having the effect of amending or altering the Franchise Agreement or Store Owner's obligations under the Franchise Agreement, or by any want of notice by PostNet to Store Owner of any default of Store Owner or by any other matter, thing, act, or omission of PostNet whatsoever.

B. CONFIDENTIALITY COVENANT

7. Guarantors shall not communicate, divulge, or use for the benefit of anyone else, any confidential information, knowledge, or know-how concerning the methods of operation of either PostNet's or Store Owner's business which may be communicated to Guarantors, or which Guarantors may learn during their association with Store Owner. Guarantors agree that any PostNet or Store Owner manuals, and any and all matters, information, knowledge, know-how, and techniques which PostNet or Store Owner designate as confidential, shall be deemed confidential for purposes of this Guarantee and Covenants, unless and until Guarantors demonstrate that the information has become public knowledge.

C. NON-COMPETITION COVENANT

- 8. Guarantors shall not, except as otherwise approved in writing by PostNet, either directly or indirectly, for themselves, or through, on behalf of, or in conjunction with, any person, persons, or legal entity:
- a. During any period that (i) Guarantors are officers, directors, employees of Store Owner, or owners of a legal or equitable interest in Store Owner, while, in either circumstance, the Franchise Agreement is in effect; and (ii) divert or attempt to divert any business or customer of Store Owner's PostNet Center to any competitor by inducement or otherwise, or do or perform any other act injurious or prejudicial to the goodwill associated with PostNet's trademarks or either PostNet's or Store Owner's business; or (iii) own, maintain, advise, operate, engage in, be employed by, make loans to, have any interest in or relationship or association with, a business which offers the same or similar products or services as those offered by PostNet Centers.
- b. For a continuous, uninterrupted one-year period commencing upon the earlier of the date that (i) Guarantors' association with or ownership interest in Store Owner terminates, or (ii) Store Owner's post-term non-competition covenant under its Franchise Agreement with PostNet terminates, either directly or indirectly, for him/herself, or through, on

behalf of, or in conjunction with any person, persons, or legal entity (including legal entities which own, are owned by, or are under common ownership with Store Owner), own, maintain, advise, operate, engage in, lease to, be employed by, make loans to, or have any interest in or relationship or association with a business which offers the same or similar products or services as those offered by PostNet Centers, and which are located in or within a ten-mile radius of the Protected Territory granted to Store Owner under its Franchise Agreement with PostNet.

- 9. Sections 7 and 8 shall not apply to the ownership by Guarantors of less than five percent of the outstanding equity securities of any company registered under the Securities Act of 1933 or the Securities Exchange Act of 1934.
- 10. Guarantors' obligations under Sections 7 and 8 of this Agreement shall be subject to the following provisions:
- a. If all or any portion of either Section is held unreasonable or unenforceable by a court or agency having valid jurisdiction in an unappealed final decision to which PostNet is a party, Guarantors shall be bound by any lesser covenant subsumed within the terms of such covenant that imposes the maximum duty permitted by law, as if the resulting covenant were separately stated in and made a part of this Agreement.
- b. PostNet shall have the right, in its sole discretion, to reduce the scope of any covenant or any portion thereof set forth in either Section, without Guarantors' consent, effective immediately upon receipt by Individual of written notice thereof; and Guarantors agree that they shall comply forthwith with any covenant as so modified.
- c. The existence of any claims which Individual may have against PostNet or Store Owner shall not constitute a defense to the enforcement by PostNet or Store Owner of the provisions of this Guarantee and Covenants.
- 10. Guarantors understand and acknowledge that any failure to comply with the confidentiality and non-competition covenants of this Guarantee and Covenants will result in irreparable injury to PostNet for which no adequate remedy at law may be available, and Guarantors consent to the issuance of, and agree to pay, all court costs and reasonable attorneys' fees incurred by PostNet in obtaining, without the posting of any bond, an *ex parte* or other order for injunctive or other legal and/or equitable relief with respect to the requirements of these covenants.
- 11. The provisions of Section 22 of the Franchise Agreement shall apply as to any interpretation or enforcement of this Guarantee and Covenants, and the provisions of Section 19 of the Franchise Agreement shall apply to any notice to either party, except that notice to Guarantors shall be sent to the address(es) set forth below beneath each Guarantor's signature.

- 1.1 Conversion Owner shall modify the Center premises in the manner set forth in Exhibit 1, to conform to PostNet's prototype plans and specifications.
- 1.2 PostNet and Conversion Owner agree that time is of the essence in connection with the construction of leasehold modifications. Conversion Owner shall complete such modifications no later than 60 days from the execution of the Addendum. In the event that Conversion Owner fails to complete modifications by such date, PostNet shall have the right to terminate this Agreement in accordance with Section 13.3 of the Agreement.
- 1.3 Upon completion of the modifications set forth in <u>Exhibit 1</u>, Conversion Owner shall submit a written request to PostNet to conduct a final inspection of the Center premises and, upon receipt of such request, PostNet shall promptly conduct a final inspection. Conversion Owner shall not open the Center for business without PostNet's written authorization.
- 1.4 Conversion Owner may at its discretion continue to operate its Current Business during construction of leasehold modifications but shall not identify itself as a PostNet Center

until receipt of PostNet's written authorization to conduct business, as set forth in Section 1.3 of this Addendum.

2. Training

- 2.1 Prior to the opening of the Center, Conversion Owner (or, if Conversion Owner is a corporation or partnership, a principal of Conversion Owner acceptable to PostNet) may, but is not required to attend the classroom training program for other new Store Owners. PostNet shall provide training, instructors, a training manual, and other materials without charge. Conversion Owner shall be responsible for any and all expenses incurred in connection with the training program including, without limitation, the costs of transportation, lodging and other meals.
- 2.2 Any reference in the Agreement to obligations by PostNet or Conversion Owner with respect to an initial training program shall be null and void, and of no effect.

3. Delay in Applicability of Conversion Owner Obligations

3.1 Conversion Owner's obligation to pay royalties and make expenditures and contributions for advertising and promotion, as set forth in Sections 3.2 and 3.3 of the Agreement, shall commence 30 days from the date of the Agreement.

4. <u>Deletions from the Agreement</u>

4.1 The following Sections of the Agreement shall be deleted in their entirety, and have no force or effect:

3.1; 3.4, 4.1; 4.3; 4.7; 4.8; 4.10; 5.10, but only to the extent that it applies to Conversion Owner's current lease; 9.7; 13.4; 14.4; and 14.9.

5. Additions to the Agreement

- 5.1 The following Section 3.1 shall be inserted into the Agreement and made a part thereof:
 - 3.1 PostNet acknowledges receipt from Store Owner of an initial franchise fee of _______, which payment shall be fully earned and non-refundable when paid, in consideration of the administrative and other expenses incurred by PostNet in entering into this Agreement, and for PostNet's lost or deferred opportunity to enter into this Agreement with others.

6. Integration

6.1 This Addendum shall be considered an integral part of the Agreement between the parties hereto, and the terms of this Addendum shall be controlling with respect to the subject

matter hereof. Except as modified or supplemented by this Addendum, the terms of the Agreement are hereby ratified and confirmed.
