## The Franchisee will own and operate a Sir Speedy Center.

- 2. THE FRANCHISE AGREEMENT STATES THAT CALIFORNIA LAW\* GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
