

To simplify the language of this Offering Circular “Sir Speedy” means Sir Speedy, Inc., Franchisor. “You” means the person or entity who buys the franchise. If the person who buys the franchise is a corporation, “you” includes all owners of the corporation.

## ITEM 1

### FRANCHISOR, ITS PREDECESSORS AND AFFILIATES

#### The Franchisor

Sir Speedy was incorporated in the State of California originally on July 9, 1968 and re-incorporated on August 9, 1996. Sir Speedy maintains its principal place of business at 26722 Plaza Drive, Mission Viejo, California 92691. Since 1968, Sir Speedy offers franchises for printing, copying, and digital service centers known as “Sir Speedy Centers”. As of December 31, 2005, there were a total of 450 franchised Sir Speedy Centers operating in 40 states, plus District of Columbia, Argentina, Brazil, Canada, Colombia, Chile, People’s Republic of China, El Salvador, Guatemala, Indonesia, Netherlands Antilles, Peru, Philippines, Poland<sup>1</sup>, Puerto Rico, Singapore, Taiwan (R.O.C.), Thailand, and United Arab Emirates.

Sir Speedy previously offered copy center franchises under the name “Copies Now” from 1985 to 1994. Many Copies Now Centers have converted to Sir Speedy Centers. As of December 31, 2005, there were 9 Copies Now Centers operating in 5 states. Sir Speedy does not own or operate any Copies Now Centers.

Sir Speedy’s Dutch affiliate, MultiCopy Netherlands, BV (“MultiCopy”), has franchised printing/copying centers under the name “MultiCopy” in Europe since 1981, with 70 centers in the Netherlands as of December 31, 2005. The MultiCopy Company, purchased January 1996 from Moore Limited Corporation, has its principal place of business in Amsterdam, and does not offer franchises in any other lines of business. All MultiCopy centers are linked to Sir Speedy’s website [www.sirspeedy.com](http://www.sirspeedy.com). Your Global Digital Network™ supports electronic file transfer between Sir Speedy and MultiCopy centers.

Except as mentioned above, Sir Speedy does not operate under any other name and does not offer franchises in any other line of business. Sir Speedy’s agent for service of process in California is the California Corporations Commissioner in Los Angeles, listed in Exhibit “B”. Sir Speedy, Inc.’s agents for service of process in other states are also disclosed in Exhibit “B”.

#### Predecessors and Affiliates

Sir Speedy has no predecessors and is a wholly owned subsidiary of Franchise Services, Inc., (“FSI”), a California corporation with its principal place of business at 26722 Plaza Drive, Mission Viejo, California 92691. FSI owns and provides certain administrative services for 5 subsidiary companies: Sir Speedy, Inc. (“Sir Speedy”), Digital Quickcolor, Inc. (“DQI”), Summit Marketing Communications, Inc. (“Summit”), MultiCopy, and Postal Instant Press, Inc. (“PIP”).

<sup>1</sup>In order to maintain continuity of the “Multicopy” name in Europe, Sir Speedy offers franchises operating under the name “MultiCopy”. As of December 31, 2005, Sir Speedy has one MultiCopy center in Poland under an Area Franchise Agreement.

DQI was incorporated in California on October 12, 1990 and has its principal place of business located at 30B Mauchly, Irvine, California 92718. DQI acts as Sir Speedy's research development and technical support organization that studies, analyzes, adapts, and recommends various evolving technology developments, which impact or may impact the printing industry and ultimately affect the products and services offered by Sir Speedy Centers. Additionally, DQI provides wholesale short run full color printing and pre-press services to Sir Speedy Centers and PIP Centers electing to become DQI dealers. DQI also provides specialized color printing and related services to FSI and its subsidiaries and to the public.

Summit is a marketing firm and advertising agency and has provided services to Sir Speedy since 1992. Summit is a Colorado corporation that was incorporated on August 12, 1996 and has its principal place of business located at 48 West Ranch Trail, Morrison, Colorado 80465.

On October 31, 1996, FSI purchased 100% of the stock of PIP from Kane-Miller Corp. and certain of its stockholders. PIP was incorporated originally in California on June 28, 1968 and reincorporated in Delaware on October 20, 1987. PIP's current principal place of business is located at 26722 Plaza Drive, Mission Viejo, California 92691. PIP has franchised printing and copying outlets since 1968 under the names PIP and PIP Printing. As of December 31, 2005, there were 211 PIP outlets in the United States, District of Columbia, and the United Kingdom. PIP has never offered and does not own any Sir Speedy Centers and Sir Speedy does not offer or own any PIP outlets. PIP has not offered franchises in any other lines of business.

FSI is a wholly owned subsidiary of KOAH, Inc., a Delaware corporation ("KOAH"). KOAH also owns 100% of Kampgrounds of America, Inc., a Montana corporation, incorporated June 3, 1960 ("KOA") with its principal place of business located at 550 North 31st Street, Billings, Montana 59101. Since its incorporation, KOA has franchised and owned campgrounds throughout the United States, Canada, Japan, and Mexico. As of December 31, 2005, there were a total of 385 operating in the United States not including the Company Owned and 33 operating in Canada not including 1 Company Owned. KOA has never offered nor owns any Sir Speedy Centers and Sir Speedy has never offered nor owned any KOA campgrounds.



#### Description of Franchises

A Sir Speedy Printing, Copying, and Digital Networking Center is a fast-paced, full-service business communication and data management facility. A center produces products and services, including graphic design, offset duplication, high-speed copying, color copying, bindery, digital services and provides other related products or services requested by a customer. Digitally based products and services are required. Jobs come to us on disk, compact disc and through the internet, and in conceptual or hard copy form. The services are media independent. Information required by a customer may be output via offset printing, color or black and white copying, color or black and white digital printing, compact disc, etc. and can be distributed before production-create, distribute, print-or after production-create, print, distribute. There is a list of the most basic products and services of Sir Speedy Centers in Section 1d of the Franchise Agreement. These products and services are in demand by businesses of all

sizes, and the general public. You will face competition from other franchised printers, independent shops, office supply stores, and commercial printers.

Sir Speedy utilizes franchising as its business strategy for expansion in the United States and abroad. We grant franchises with care to individuals we believe are qualified financially, have acquired the business acumen to handle running one's own business, have the personality traits most desirable to follow the Sir Speedy System to enhance the brand and have a burning desire for success.

There are no industry specific regulations relating to owning and operating a printing and copying center.

## ITEM 2

### BUSINESS EXPERIENCE

#### **President, Chief Operating Officer, Director: Daniel D. Beck**

Mr. Beck has been the President of Sir Speedy since October 1996. Mr. Beck is also a director. Previously, he was Vice President of Franchise Services since January 1989. Before that, Mr. Beck was Assistant Vice President of Franchise Services from March of 1986. Before Mr. Beck's employment with Sir Speedy, he was Vice President of Sales for KOA in Billings, Montana and in various other capacities from November 1977 to March 1986.

#### **Chief Financial Officer, Secretary, Treasurer, Director: Daniel J. Conger**

Mr. Conger has served as the Chief Financial Officer, Secretary, and Treasurer since August 1992. Mr. Conger is also a director. Previously, Mr. Conger was Vice President of Finance for Vans, Inc. in Orange, California from 1990 through 1992. Before that, he was with Western Digital Corporation in Irvine, California from 1986 through 1990, Emerson Electronic in St. Louis, Missouri from 1984 through 1986 and Burroughs Corporation in Detroit, Michigan from 1977 through 1984.

#### **Senior Vice President: Richard A. Lowe**

Mr. Lowe became Vice President of Franchise Services in March 1998 and was appointed Senior Vice President on January 1, 2005. During this time, Mr. Lowe also acted as President of DQI in 2004. Mr. Lowe is also a director. Previously, Mr. Lowe served as Assistant Vice President of Strategic Development from December 1994 to March 1998 and before that, he served as Western Region Operations Manager. Mr. Lowe joined Sir Speedy in June 1989 as Director of Copies Now. Before joining Sir Speedy, Mr. Lowe was a copy product Sales Representative for Eastman Kodak in Rochester, New York.

#### **Franchise Operations Manager: Matthias D. Paretsky**

Mr. Paretsky joined Sir Speedy as Franchise Operations Manager in April 2003 and is in charge of the Print Management University training. Prior to that, Mr. Paretsky spent nine years with Kinko's, Inc., from January 24, 1994 to March 13, 2003 as a Branch Operations Manager, and in their corporate training department.

**Assistant Vice President, International Development: Randal M. Long**

Mr. Long became Assistant Vice President of International Development in November 1998. Previously he was Senior Director International Development and Director International Development from October 1997 and manager of International Operations from January 1995. Mr. Long joined Sir Speedy in January 1983 as a Business Management Consultant.

**Vice President, Franchise Services: Sally Coon**

Ms. Coon is Vice President of Franchise Services for Sir Speedy. Previously she served as PIP's Vice President of Franchise Support and Training since December 2003 and Sir Speedy's Assistant Vice President from 1998 to 2003. From 1997 to 1998, Ms. Coon was U.S. Operations Manager for Sir Speedy, and from 1994 to 1997, she was its Business Services Manager.

**Assistant Vice President, Information Technology: Christian Lau**

Mr. Lau has been employed by FSI since November 2004 as Assistant Vice President, Information Technology and provides IT services to Sir Speedy. Previously, he was employed by Jupiter Media-Picture Arts located in Pasadena, California and New York City, New York as the Director of Information Technology from February 2003 to November 2004. From January 2000 to February 2003, Mr. Lau worked for Reed Elsevier PLC, in Sand Diego, California and New York City, New York as their Systems and Technology Manager. From February 1996 to February 2000 he was actively engaged as an Intelligence Specialist with the United States Navy, Department of Defense in San Diego, California and Yokosuka, Japan.

**Assistant Vice President, Strategic Development: Kelly Kimberlin**

Mr. Kimberlin has been an employed by FSI since October 20, 2004 as Assistant Vice President, Strategic Development and provides strategic development services to Sir Speedy. Prior to this, he was employed as the Director of Research and Development of DQI, located in Irvine, California from April 2001 to October 2004. Mr. Kimberlin was the Director of E-Business from April 1999 to April 2001 for Sir Speedy. From July 1996 to February 1999, Mr. Kimberlin was employed as the Sales and Marketing Manager for Page One, Inc., located in Irvine, California.

**Director: Carl E. Kimball**

Mr. Kimball has been the President of Summit since its inception in January 1992 and is a director for Sir Speedy. Previously, Mr. Kimball was the Vice President of Marketing of Sir Speedy from March 1985 to December 1991. In the 5 years before joining Sir Speedy, Mr. Kimball was the Senior Vice President of Marketing for Doyle Dane Bernbach Advertising in Denver, Colorado.

**Chief Executive Officer and Director: Don F. Lowe**

Don Lowe is the President and Chief Executive Officer of Franchise Services, Inc., and is Chief Executive Officer of Sir Speedy, DQI, Summit, MultiCopy and PIP. Previously, Mr. Lowe served as President of Sir Speedy from April 1981 to September 1996. Before joining Sir Speedy, Mr. Lowe served as Senior Vice President for Kampgrounds in Billings, Montana and joined Kampgrounds in 1972.

## **Franchise Brokers**

Sir Speedy does not use Franchise Brokers.

### **ITEM 3**

#### **LITIGATION**

Leo J. Beauclair, Steven Beauclair, Lee Beauclair vs. Sir Speedy, Inc. (American Arbitration Association, Case Number 80Y1140027398LME). On July 24, 1998, the Claimants (hereafter, "the Beauclairs", former Franchisees, filed a Demand for Arbitration alleging that Sir Speedy intentionally misrepresented the viability of Ponce, Puerto Rico in supporting a Sir Speedy Center. The Beauclairs owned and operated a Sir Speedy Center in Ponce for approximately 17 months and sought over \$400,000, plus rescission. The hearing took place in July 1999. The Beauclairs were awarded rescission and damages of \$278,000, plus interest, attorneys' fees and costs.

Other than this one action, no litigation (or arbitration) is required to be disclosed in this Offering Circular.

### **ITEM 4**

#### **BANKRUPTCY**

No person previously identified in Items 1 and 2 of this Offering Circular has been involved as a debtor in proceedings under United States Bankruptcy Code required to be disclosed in this Item.

### **ITEM 5**

#### **INITIAL FRANCHISE FEE**

You must pay an initial franchise fee of \$25,000 (plus any applicable sales tax). You pay \$10,000 deposit with your signed Franchise Agreement, and this deposit will be refunded to you if your chosen market or your financing is not approved by Sir Speedy, or if our Franchise Review Committee does not approve your application. Otherwise, the \$10,000 deposit is non-refundable. You pay the balance of the franchise fee of \$15,000, before you attend the two-week initial training program. This payment of \$15,000 is non-refundable.

You may purchase additional Sir Speedy Centers for the multiple franchise fee offered at the time. Currently, that franchise fee is \$7,500 for an approved location outside your protected territory (as defined in Item 12), or \$1,000 for location inside your protected territory. These franchise fees are non-refundable as stated above. You must obtain Sir Speedy's prior written approval to open an additional Sir Speedy Center, and sign a new Franchise Agreement and an Outside Territory Multiple Center Addendum similar to Exhibit "F" for a Multiple Center outside your protected territory, or an Inside Territory Multiple Center Addendum similar to Exhibit "F" for a Multiple Center inside your protected territory. You must not be in default of your existing Franchise Agreement.

#### **Start Up Costs**

You must also pay \$30,000 to Sir Speedy for training and opening costs (along with any applicable sales tax required by your state), for services and items we provide as site location assistance, lease negotiation assistance, classroom training, transportation for 2 to training, lodging and most meals at training, the training at opening of your Center, your opening promotional activities, mailing list, and

beginning inventory (see Pre-Opening Obligations and Continuing Obligations in Item 11). You must pay the training and opening costs, before attending Sir Speedy training school, or within 90 days after you sign your Franchise Agreement, whichever is first to occur.

If you are unable to adequately complete your work at training school, you may be disqualified and Sir Speedy will refund your paid in training and opening costs of \$30,000 and terminate your Franchise Agreement. Other than as stated above, the franchise fee, training, and opening costs are not refundable.

**Notes:**

1. All fees are imposed by and payable to Sir Speedy and are non-refundable. However, Continuing Franchise Fees are rebated in accordance with Exhibit "B" of the Franchise Agreement.
2. Continuing Franchise Fee for independent print/copy shops that desire to convert to a Sir Speedy franchise will be on different terms than provided herein.
3. All fees are payable to the Sir Speedy Advertising Fund, and are non-refundable. You and other Franchisees may join together to form a local advertising cooperative to collect dues and conduct joint advertising. Typical monthly dues range from \$50 to \$405.
4. The training fee applies to additional people sent to training by you over and above the two provided for in your Franchise Agreement.
5. An audit may cost anywhere from \$0 to \$3,500 depending on the scope of the audit.

**Notes:**

- The initial franchise fee and start-up costs are discussed in detail in Item 5. Sir Speedy does not finance these fees and costs. Franchise fees for an independent print/copy shop converting to a Sir Speedy may be different.
- The purchased equipment includes prepress equipment and software, bindery equipment, large format equipment, mailing services equipment and software, and furniture and office equipment. See Exhibit "A" of Franchise Agreement for details. An estimated financing monthly payment for the purchased equipment would be approximately \$1,800 over a period of 60 months with a 1% buy-out. (However, actual terms and rates depend on your credit and other qualifications.) The leased equipment consists of two digital print engines, one color and one black and white. An estimate monthly lease payment for both machines combined is approximately \$2,857 for 36 months. The retail value of the two leased machines, if purchased rather than leased is approximately \$102,000.
- You will need capital to pay for initial security and utility deposits, business permits, initial Yellow Pages advertisement, initial insurance costs and tenant improvements. Leasehold improvements vary from \$0 to \$25,000 or more, and, will be negotiated with the landlord. In some cases, you will pay for the site improvements and sometimes the landlord will offer an allowance, in which case they will be paid for in full or in part by the landlord, and payment will then be made via the regular rent payments. You will also need capital to support your ongoing expenses, such as rent, lease payments, payroll, utilities, Continuing Franchise Fees, advertising and supplies, etc., to the extent these costs are not covered by sales revenues. New businesses often generate a negative cash flow. Sir Speedy estimates that the amount given will be sufficient to cover ongoing expenses for up to a 20-month start-up phase. This is only an estimate, however, additional working capital may be necessary during this start-up phase, and after. Your actual break-even point will depend on factors such as: how much you follow Sir Speedy's methods and procedures; your management skill, experience and business acumen; local economic conditions; the local market for the product; the prevailing wage rate; competition; the sales level reached during the initial period; and any equipment upgrades. Therefore, Sir Speedy cannot accurately predict how long it will take you to reach your break-even point, if ever. Initial expenses for non-owner managed Centers may be considerably higher and may require a longer start-up period. Sir Speedy relied on its 30 years of experience in the printing and reproduction business to compile these estimates. You should review these figures carefully with a business advisor before making any decision to purchase the franchise.
- The figures given, assume the purchased equipment is purchased and the leased equipment is leased. The digital print engine copiers are typically leased, and the equipment package is typically purchased-financed.

## ITEM 8

### RESTRICTIONS ON SOURCES OF PRODUCTS AND SERVICES

You must obtain certain basic computer, hardware and software, pre-press, duplication, and finishing equipment to adequately serve your customers' needs. The total equipment package may be obtained from any source, including Sir Speedy. Sir Speedy specifies by name equipment determined to be most efficient for the uses anticipated. You may obtain comparable equipment with equivalent function, capacity and quality if approved by Sir Speedy.

Approval for equivalent equipment is determined by product tests, both in the field by you and by equipment testing done by Sir Speedy at its own facilities. All approved equipment must be manufactured by a reputable graphic arts supplier able to provide national service. The testing period usually varies between one and six months and is at no cost to you. If approved, Sir Speedy will notify the supplier. Sir Speedy does not have any affiliates who are approved suppliers of required equipment.

In addition to the equipment package, you must have two digital print engines, which must be on the premises. These machines are leased directly from the vendors.

We estimate that the equipment package will be approximately 28% to 31% of the cost to establish the Sir Speedy Center. (Additional equipment purchased from required working capital during the first 12 months must be approved by Sir Speedy).

In the year ending December 31, 2005, Sir Speedy's gross revenues from the sale of equipment to Sir Speedy Franchisees was \$0.00. Sir Speedy is selling the initial equipment package to you at cost.

Several of Sir Speedy's suppliers provide Sir Speedy "credits" for each transaction consummated with you. The credits amount to 1% to 5% of the purchase price and are used by Sir Speedy to acquire test equipment from that supplier for its national training center and corporate office, and to support training venues.

Sir Speedy's various national contracts with many equipment manufacturers/distributors give discounted pricing to you based on volume purchasing of up to 50% off list pricing. Sir Speedy does not require you to deal with any particular vendor as a condition to receive any Franchise benefits.

Sir Speedy does not arrange financing from other sources.

Sir Speedy does not receive direct or indirect payments for placing financing.

Sir Speedy does not guarantee your obligations to third parties.

Sir Speedy does not have any past or present practice or intent to transfer, assign, discount, or sell to a third party, in whole or in part, any note, contract or other instrument signed by you, but Sir Speedy reserves the right to do so in the future.

## ITEM 11

### FRANCHISOR'S OBLIGATIONS

#### Pre-Opening Obligations

Before you open your business, Sir Speedy will:

1. Provide you with advise, upon request, in obtaining financing for your Sir Speedy Center (Franchise Agreement, Section 3f);
2. Review the proposed market area for business counts, traffic flow, development or redevelopment in the area, business types, business climate, competition, availability of

sites, location of suppliers and other Sir Speedy Centers (Franchise Agreement, Section 3a);

3. Provide you with site selection approval. We will use our best efforts to approve or disapprove your proposed site within 14 days from the date you submit your proposal along with all the other information about the site, which we may reasonably require. Neither Sir Speedy nor any affiliate intends to own the premises for your site, but we reserve the right to do so (Franchise Agreement, Sections 3b and 3c);
4. Provide you with a custom layout for your Sir Speedy Center (Franchise Agreement, Section 3c);
5. Deliver to you all supplies, inventory, and proprietary items (Franchise Agreement, Sections 3d and 3g); and
6. Provide you with, and assist in the delivery and installation, of the equipment and furniture purchased from Sir Speedy (Franchise Agreement, Section 3e). Freight, handling, installation and taxes are in addition to the Equipment Purchase Price.

### **Initial Training**

Before opening, Sir Speedy will train you and one other person at our Print Management University currently located at our corporate facility in Mission Viejo, California. You may bring additional people to the training program (over the 2) at your expense. The current training cost for an additional person is \$1,000 (transportation and lodging are your responsibility). This mandatory, comprehensive training session currently begins with an orientation on a Sunday evening and runs for 2 weeks. Total instructional time currently runs for 88.5 hours. The objective of our initial 2-week training program is to thoroughly train you in our four operating systems: production management, marketing and sales management, business and financial management, and employee management. You must satisfactorily complete the training program.

The instructional materials and methods include a pre-attendance, a set of manuals, printed handouts, audiovisual presentations, hands-on instruction on actual equipment, role-play, case studies, and group interaction. Sir Speedy pays in full training expenses for two people to attend this initial training session including round trip transportation, lodging (one room, double occupancy), and some food (continental breakfast and lunch is provided every day of classroom training). Our initial training sessions are held 4 to 6 times per year. Hours of instruction per operating system are as follows:

You leave the initial training program with a customized business plan to implement and follow during the first year of operation. There are no other mandatory initial training programs.

### **Continuing Obligations**

When you begin operation, Sir Speedy will:

1. Provide you an opening and training representative to help you set up your center for up to 5 days (Franchise Agreement, Section 3i);
2. Provide you with a 6 month promotional program, including telemarketing and direct mail, through outside service providers and Sir Speedy personnel (Franchise Agreement, Section 3i);
3. Assist you in establishing a telemarketing program to follow up the direct mailings and set up appointments (Franchise Agreement, Section 3i.);
4. Provide you with promotional materials to distribute to your targeted customers (Franchise Agreement, Section 3i);
5. Provide you with an experienced digital training consultant who will spend up to 3 days on site, training you and your staff (Franchise Agreement, Section 3i);
6. Provide you with an experienced sales trainer who will spend 2 days with you on sales calls (Franchise Agreement, Section 3i);
7. Loan you a copy of Sir Speedy's Confidential Operations Manuals and Training Manuals (Franchise Agreement, Section 3j); and

These manuals currently include:

- Business Model;
- Business and Financial Management Manual;
- Employee Management Manual;
- How to Hire, Train and Manage a Salesperson Manual;
- Marketing Manual;
- Operations & Production Management;
- Hazard Communication Program Manual; and
- Health & Safety Program Manual.

These manuals are confidential and remain Sir Speedy's property. Sir Speedy may modify, add to, or delete from the manuals; the modifications will not alter your status or rights under the Franchise Agreement. The Table of Contents for each manual is attached as Exhibit "C".

8. Provide you with the current available resources, which as of 2006, include:
  - Periodic consulting and assistance by field representatives;
  - Toll-free customer support lines for telephone consulting;
  - Periodic marketing materials and assistance (described in detail below);

- Periodic seminars, regional meetings and an annual convention;<sup>1</sup>
- A monthly newsletter;
- Free audio, video tape and CD resource library;
- Advice and information about new developments in the printing, copying, and graphic arts industry;
- Advertising materials described below;
- Access to our proprietary intranet: Sir Speedy Net, including all training and industry information; and
- Access to our SirSpeedy.com website, which includes Sir Speedy MyDocs<sup>®</sup> online ordering, online proofing, send-a-file and document management systems.

Sir Speedy is not obligated to perform these services to your particular level of satisfaction, but as a function of our experience, knowledge, and judgment (Franchise Agreement, Section 3k).

### **Marketing Materials and Advertising Programs**

Marketing is a major emphasis of the Sir Speedy System. Sir Speedy creates an elaborate set of marketing materials at no additional cost to you for your local marketing use. These materials currently are files for local print advertisements, yellow page layouts, files for promotional items for distribution to customers, files for personalized materials (e.g. memo pads), annual calendars, and monthly newsletters. In addition, we currently have complete marketing packages such as Our Strategic Vision, a Document Management marketing program, Color Imaging Marketing Kit, Key Prospect Mailing Program, Scan to Archive Marketing Kit, Variable Printing Marketing Program, Telemarketing For Success/Sales Letters, an annual network marketing and business planning kit, and MyDocs Marketing kit and a Document Management Marketing kit. There are a number of additional marketing items for a nominal charge, including Holiday Gift Bags, Display Booth rental, Point-of-Purchase Brochures, Presentation Folders and Portfolios, and more. These products and services may be modified, deleted, or enhanced at any time.

Sir Speedy also maintains, for your benefit a network-wide Internet presence at [www.sirspeedy.com](http://www.sirspeedy.com). The main purpose of this website is to raise awareness of the capabilities of the Sir Speedy network. In addition, each center is given a custom website at [www.sirspeedy.com/yourcity](http://www.sirspeedy.com/yourcity) that can be customized and personalized by you. The individual website includes ecommerce functionality, online ordering functionality, online proofing functionality, send-a-file functionality, and functionality for document management. This service may be modified, deleted, or enhanced at any time. Additionally, the current online system allows for individualized online ordering catalogs, advanced document management features (including document archiving, searching, retrieving, and organization) to be utilized by each center for the benefit of their customers. These services are provided at little or no cost to you.

Sir Speedy also has a Network Advertising Program to promote the Sir Speedy brand on a national basis, currently through national cable television commercials, a direct mail program, special promotions, and various other marketing and advertising materials. The Network Advertising Program is not directed to any particular local area. The national television commercials are also available for your use in local markets. These local television commercials allow for center personalization and are

<sup>1</sup> The annual convention and certain seminars have an attendance fee. Locations are generally in large cities throughout the county and are given from year to year, on different business operations topics. Costs for the seminars range from \$0 to \$140 (most are free). designed to tie-in to the national advertising campaign. Radio commercials are also available for local use, although radio is not always included in the national media campaign.

A national public relations campaign, along with customizable materials and information for local PR functions are also provided by Sir Speedy as additional support.

All advertising for the Network Advertising Program is currently created by Summit. Summit generates typical advertising agency commissions for placement of media and creative development. Sir Speedy pays for its Network Advertising Program (including agency commissions) through a network-advertising fund ("Ad Fund"). You must pay weekly Advertising Fees to the Ad Fund of either 1% or 2% of your weekly gross sales. The Advertising Fees are deposited into a separate bank account that Sir Speedy administers.

Sir Speedy allocates 100% of the Ad Fund revenue to the network ad program and not to any general administrative expenses. The Ad Fund does not otherwise benefit Sir Speedy or any affiliate. Of the Ad Fund expenditures in 2005, 63% was spent on media, 12% for production of advertising and marketing materials, 13% for Internet-related costs, 10% for direct mail, and 2% for other costs. Ordinarily, Ad Fund contributions will be spent in the fiscal year they are collected. The Ad Fund is not used to advertise the sale of franchises.

The Ad Fund pays for the development and maintenance of the network and individual web sites, except for that portion of the web site with information on selling franchises, which is paid for separately by Sir Speedy.

The Ad Fund is audited annually by an independent Certified Public Accounting firm. Sir Speedy will provide to you the annual audit.

Sir Speedy has an Owners' Marketing Advisory Council (OMAC) currently made up of 8 Franchisees who have been asked by Sir Speedy to serve. Sir Speedy consults with OMAC 2 to 3 times per year on all areas of its advertising and marketing programs and promotions. OMAC serves in an advisory capacity and may be changed or dissolved by Sir Speedy in the future.

### **Cooperative Advertising**

Franchisees in the same geographic area may form a local advertising cooperative association (ACA) to conduct cooperative local advertising. If a majority of Franchisees in your area want to form an ACA, you must join and contribute dues agreed to by the majority. Sir Speedy will not be a member, but will act in an advisory capacity. Geographic areas are defined by the Dominate Market Area ("DMA") as defined by the radio and television industries. The ACA members themselves administer the ACA, create the ACA rules, and enforce those rules. (Generally, an ACA will have formal Bylaws and Articles of Association prepared, but this is not required by Sir Speedy for an ACA formation). Sir Speedy will recognize an ACA upon a majority of signatures of Franchisees in the area and will provide consultation and advice concerning cooperative advertising in the area. Sir Speedy cannot form, change, or dissolve an ACA without a majority vote of that ACA's members. ACA's are not required to prepare annual financial statements. If there is an ACA in existence in your prospective area, you must join it and should obtain information concerning dues and advertising benefits. You may preview its ACA Bylaws and Articles upon request.

You may develop advertising materials for your own use, at your cost, but materials must conform to Sir Speedy's guidelines provided to you for use of its logos and trademarks.

## **Computer Requirements**

You must have computerized pricing and estimating software and hardware (Franchise Agreement, Section 2b and Exhibit "A" of the Franchise Agreement).

The Sir Speedy selected software currently is the latest version of PrintSmith manufactured by EFI/PrintSmith, 17250 N. Hartford Dr., Scottsdale, Arizona 85255, telephone number (800) 731-2618. The program manages cost files of both materials and production, estimates and invoices, maintains customer history data, accounts receivable, and can create aging and sales analyses. EFI/PrintSmith provides telephone support, software updates, and maintenance for 180 days with initial software package at no charge to you as part of Sir Speedy's equipment package. You can purchase a continuing maintenance agreement through different pricing plans and Sir Speedy recommends you do so. Sir Speedy has no affiliation with EFI/PrintSmith and receives no direct or indirect payments (other than volume discounts for its Franchisees) for utilizing PrintSmith in its equipment package.

There is a similar pricing software program called Printers Plan (not available in the current Sir Speedy package) which Sir Speedy Centers used before PrintSmith, as well as several other printing estimator programs.

The Sir Speedy selected hardware is a personal computer and a laser printer; PrintSmith system requires a computer and printer. You must obtain the complete equipment package, which includes the computer, the printer, and the software, either, from Sir Speedy or elsewhere. Individual pieces may not be separated out of our package.

Sir Speedy does not have independent access to the information and data maintained on your software, but it reserves the right to do so. You are not required to upgrade any particular piece of software or hardware; however, you must maintain the full capabilities of a Sir Speedy Center, including implementing any changes in the Sir Speedy System.

You must provide electronic file transfer capabilities for your customers through the website, [www.sirspeedy.com](http://www.sirspeedy.com). You must also be connected to Sir Speedy Net and have high-speed internet access obtained through a local service provider.

## **Site Selection**

Sir Speedy will provide you with site selection approval. Sir Speedy will consider zoning, signage requirements, traffic flow, parking, site size and proximity to potential customer concentrations and proximity to other Sir Speedy Centers. Site selection is not an exact science and Sir Speedy does not guarantee the viability of any location. Franchisor will use its best efforts to approve or disapprove your selected site within 14 days from the date you submit a prospective site for approval. You will typically open your Sir Speedy Center within 180 days after you sign a Franchise Agreement. The factors that may affect how quickly you will open your Center include lease negotiation, obtaining financing, tenant improvements and build-out requirements, weather conditions, shortages and any delayed delivery or installation of equipment fixtures and signs.

## **ITEM 12**

### **TERRITORY**

Except as provided below, we will give you a protected territory where Sir Speedy will not establish another Sir Speedy Franchise or a company-owned Sir Speedy Center. The size of the

protected territory varies according to the number of businesses in the area, and will be at least one-half mile radius. You have no minimum sales quota to maintain your protected territory. There are no circumstances that permit Sir Speedy to modify your protected territory without your consent. You may advertise and take orders from customers inside or outside your territory, including inside another Sir Speedy Franchisee's territory, and other Sir Speedy owners (including Sir Speedy's company owned centers) may have and solicit customers in your territory. You have the exclusive option to open additional Sir Speedy Franchises in your territory upon written application and approval by Sir Speedy. You have a non-exclusive option to open additional Franchises outside your territory, but not within another Sir Speedy Franchisee's territory, upon written application and approval. The Franchise Agreement grants you a single Sir Speedy Franchise for a designated location or any approved relocation. Sir Speedy will approve a relocation based on the same criteria it uses in approving the original location.

We will not grant a protected territory in dense Metropolitan areas and Sir Speedy may grant Franchises in numerous locations in these areas. A dense Metropolitan area is defined as a central business district or central downtown area of large, metropolitan cities with a high concentration of businesses. We will tell you if your application submitted requests a city that is considered to be a dense metropolitan area.

SIR SPEEDY'S AFFILIATE, PIP MAY HAVE OR MAY ESTABLISH PIP OUTLETS IN YOUR PROTECTED TERRITORY AND SIR SPEEDY MAY HAVE OR MAY ESTABLISH SIR SPEEDY CENTERS IN A PIP FRANCHISEE'S PROTECTED TERRITORY. SIR SPEEDY OR AN AFFILIATE MAY ESTABLISH OR ACQUIRE OTHER PRINTING/COPYING COMPANIES IN THE FUTURE, WHICH MAY HAVE OR OPEN OUTLETS IN YOUR TERRITORY.

Sir Speedy owns a Copyright Registration Number TX4-592-625 dated July 22, 1997 on its publication "How to Hire, Train & Manage a Salesperson" (including Salesperson Training Manual). Sir Speedy does not own any other patents or registered copyrights. Sir Speedy's operations manuals and marketing materials are confidential and proprietary, and may only be used in authorized manners. Although not registered, Sir Speedy claims a copyright in these materials. You do not receive any rights in any proprietary or copyrighted materials.

#### **ITEM 15**

##### **OBLIGATION TO PARTICIPATE IN THE ACTUAL OPERATION OF THE FRANCHISE BUSINESS**

You must directly supervise and participate in the day-to-day operations of the Sir Speedy Center or the Sir Speedy Center must be directly supervised "on-premises" by a manager who has successfully completed Sir Speedy's initial training. The manager must sign a written agreement to maintain confidentiality of the proprietary information described in Item 14 and to conform to the covenants not to compete described in Item 17. There is no limitation in who you may hire for a manager, except you cannot hire a person who concurrently works for or owns a similar business. The manager need not have an equity interest in the Franchise. Caution: Sir Speedy Centers that are not directly managed and operated by you will require a greater marketing effort to achieve profitability since expenses tend to be higher than in owner-managed and operated Sir Speedy Centers. Sir Speedy strongly recommends an owner-operator involvement.

#### **ITEM 16**

##### **RESTRICTIONS ON WHAT FRANCHISEE MAY SELL**

You must offer and sell only those goods and services that Sir Speedy has approved. Sir Speedy has the right to change the types of approved services consistent with business technologies. You may not conduct any business other than that of the Sir Speedy Center at the franchised location, except upon Sir Speedy's written authorization. There are no restrictions on the customers you may serve.

**RENEWAL, TERMINATION, TRANSFER AND DISPUTE RESOLUTION**

**SIR SPEEDY MAKES NO REPRESENTATIONS AS TO ACTUAL, AVERAGE, PROJECTED, OR FORECASTED PROFITS, EARNINGS, OR SALES YOU MAY EXPECT FROM THE OPERATIONS OF A SIR SPEEDY CENTER.**

United States Sir Speedy Centers in business over 1 year averaged \$803,045 in gross sales for the 12-month period ending December 31, 2005. This average is based on 390 reporting franchises.\*

The 2005 figures reveal that 72.3% or 282 of the 390 reporting Centers actually attained or surpassed \$803,045; 57.9% or 226 Centers exceeded \$900,000; 24.1% or 94 Centers exceeded \$1,000,000; 12.8% or 50 Centers exceeded \$2,000,000; and 4.8% or 19 Centers exceeded \$3,000,000.\*\*

Of the 390 Centers in this report, 6 had been opened and operating for 1 to 5 years; 38 Centers had been opened and operating for 6 to 10 years; and 346 Centers had been opened and operating for over 10 years.\*\*

The sales figures, although unaudited, are based upon the actual reported sales volumes of Franchisees. The earnings claim figure(s) does (do) not reflect the costs of sales or operating expenses that must be deducted from the gross revenues or gross sales figures to obtain your net income or profit. The best source of cost and expense data may be from franchisees and former franchisees, some of whom may be listed in Item 20.

Sir Speedy offers substantially the same services to each of its Franchisees. The type and extent of services offered to the public by each individual Franchisee may vary somewhat with each Franchisee. The sales volume attainable by a Franchisee is largely dependent on the type and quality of service offered to the public as well as individual sales and marketing efforts.

#### **Assumptions That May Be Used in Developing Projections**

**(Percentages given for cost of sales and for salaries and wages are recommended ranges)**

**Cost of Sales** - Consumable raw materials and supplies for the production of digitally printed material (where applicable), copying, preparation, large format printing, mailing services and bindery, the cost of goods purchased for resale such as business cards, offset printing and rubber stamps. Cost of sales optimally should range from **28% to 32%** for efficiency.

**Accounting and Legal** - Expenses required for basic monthly bookkeeping and financial statement preparation. Fees may increase as sales volumes increase.

**Selling and Advertising** - **1%** of gross sales for network Advertising Fee for the first year of operation and **2%** of gross sales after first year, plus costs associated with yellow page advertisement, direct mail and a dedicated full-time salesperson each year.

**Automobile** - Based upon estimated business miles, expensed according to the appropriate IRS regulation.

**Depreciation** - Original equipment cost depreciated over a 3-7 year period using the straight-line method with additional equipment added as necessary to meet sales demands.

**Office Supplies** - Cost of miscellaneous supplies used in operating the business.

**Rent** - Approximate monthly rent of a new Center ranges from \$1,200 to \$4,500 per month depending on the location of the Center. Some areas may be higher.

**Repairs and Maintenance** - Costs associated with operating presses and cameras at various sales volumes, approximately **1%** (Offset Equipment Upgrade Option only). Monthly costs of copier maintenance agreements.

**Continuing Franchise Fees** - **4%** of gross sales for the first year of operation and **6%** of gross sales after the first year. (See Exhibit "B" of the Franchise Agreement for Continuing Franchise Fee rebates).

**Salaries and Wages** - Salary figures should reflect the staffing requirements for counter sales, and a production and/or binding person, and optimally should range from **20% to 25%** of sales for efficiency, including employer's share of FICA, FUTA, and SUTA taxes. Owner's compensation is not included.

**Taxes - Personal Property** - Varies depending on individual state, county and city laws.

**Telephone** - Expenses associated with having two business lines, an internet connection, plus increases related to levels of sales activity.

**Utilities** - Expenses associated with operating the various equipment, etc.
