Franchisee Prospects

We can award our Franchisees compensation for introducing Franchisee prospects to us, if the prospect actually signs a Franchise Agreement with us. This compensation may be in the form of a gift certificate or money. In some states the franchise may have to register as a franchise broker or sales person to accept this compensation.
